



# Videography Contract

This agreement is between PIX & FLIX (hereafter "PIX & FLIX" or "we") and \_\_\_\_\_ (hereafter "you" and/or "client") for wedding/event video coverage. These terms apply to our agreement.

**1. EXCLUSIVITY AND AUTHORITY:** PIX & FLIX will act as the sole and exclusive videographer for your event on \_\_\_\_\_, and that you understand Pix & FLIX will do their best to work with family members and others with cameras but PIX & FLIX will not be held accountable for problems that arise when family members and others with cameras take up too much time. PIX & FLIX will work closely with and cooperate with the wedding/event photographer if there is one.

**2. PAYMENT POLICY, CANCELLATION, TRAVEL COSTS:** You agree to pay Pix & Flix a grand total of \_\_\_\_\_ for their services. There is a \$100 Deposit to reserve PIX & FLIX productions for your wedding/event date. The remaining balance of the fee \_\_\_\_\_ is due before the wedding day unless agreed upon in writing. PIX & FLIX accepts payments of cash, checks, MasterCard or Visa. Deposits are not refundable under any circumstances. **3. SPECIFIC COVERAGE AND RIGHTS:** If you have any specific video needs, you must clarify them before the event. PIX & FLIX videographers and video editors will apply their best judgment and creative license to the production. If there are any items that you wish to be included in the production/post production of your video they must be submitted by the date of your wedding/event unless other arrangements have been made. You are hiring PIX & FLIX to make a video production for private home use and indemnify PIX & FLIX for any potential violation of the rights of participants. You warrant that you have the legal right to any photos, audio, tapes, CD's, videotapes or other elements delivered or used by PIX & FLIX for the purpose of inclusion into final production of your video.

**4. LIMITATION OF LIABILITY:** While every effort is made to produce and deliver outstanding video and audio of the Wedding/Reception or Event, liability for any poor audio and lack of video documentation due to the unforeseen absence of necessary individuals, unforeseeable technical difficulty, uncontrollable and unforeseeable equipment failure, insufficient time, lack of cooperation, or to any event beyond the reasonable control of PIX & FLIX is limited to monies received for services, minus tape, travel, and other misc. costs. This limitation applies to all production and post-production services rendered.

**5. RETENTION OF MASTER TAPES:** PIX & FLIX owns and will retain all camera and Edited Masters of Wedding/Reception for an unspecified amount of time, and reserves the right to use any part of the Master Tapes for marketing/promotional purposes.
